Target Sports USA (“Target Sports,” “we,” “our” or “us”) offers its customers the opportunity to participate in the AMMO+ Business Membership (the “Ammo” “Membership” “Plus” or “Program”). The terms and conditions below apply to the Program and are between you (“you” “customer” “Dealer” or “Member”) and Target Sports USA.

If you sign up for the AMMO+ Membership you accept these terms, conditions, limitations, and requirements, as well as the other terms, conditions, limitations, and requirements available on the [targetsportsusa.com](http://targetsportsusa.com) website, as each may be changed over time with or without notice to you (the “Terms”).

**MEMBERSHIP TERM AND BENEFITS**

The AMMO+ Membership is a subscription-based program offered exclusively for Target Sports USA customers. A one-year membership is available for an annual fee purchased online at [targetsportsusa.com](http://targetsportsusa.com) or when you place an order over the phone. The Membership term is one (1) year and may be renewed pursuant to the Terms. The initial term combined with the renewal term constitutes the “Membership Term.”

**DURING THE MEMBERSHIP TERM, MEMBERS RECEIVE:**

- Free standard shipping on all orders
- Member’s only offers and promotions

Your Membership benefits start as soon as you sign-up and pay for an AMMO+ Business Membership.

**PRICING:**

Program pricing and discounts apply to ammunition. In rare cases, we may exclude products from the Program at our sole discretion. Purchases may be subject to taxes which are not subject to the Program’s discount. Look for the AMMO+ price to know the product’s discounted price.

**FREE SHIPPING:**

Members will receive free standard shipping on every order regardless of order total. Free shipping only applies to standard shipping fees to U.S. destinations, all other fees with UPS are the customers responsibility. (example: address change, delivery hold, etc.)

Periodically Members will receive limited time offers via email or text. Members are encouraged to keep their email address current to ensure they receive the most out of this benefit.

## AMMO+ MEMBERSHIP ADDITIONAL DETAILS

As a member of our service, you are entitled to associate up to two addresses with your profile without incurring any additional charges. If you wish to associate more than two addresses with your account, an additional cost will apply. To add extra addresses, please get in touch with our customer service team at 860-426-9886. They will assist you in setting up accounts with the desired number of addresses and provide any necessary information regarding associated fees or modifications to your subscription plan.

## MEMBERSHIP CANCELLATION:

Members cannot cancel their Membership once benefits have been collected. Refunds will not be made for any AMMO+ Memberships even if the Member did not use any of the benefits during the Membership term. ## MEMBERSHIP AUTO-RENEWAL:

Members receive a renewal notice approximately three (3) days prior to their Membership renewal billing date which includes the Membership expiration date and any applicable renewal instructions. If we have a valid email address on file, the Member receives this notice by email. To ensure timely renewal, please login to your Account at [targetsportsusa.com](http://targetsportsusa.com) to verify or make changes to your billing or shipping address. Members may choose to opt out of the auto-renew feature for their Membership. If Member does not wish to participate in the auto-renew process or elects not to renew, they should call the Target Sports USA Customer Service Department at 860-426-9886 or by email to [Ammoplus@targetsportsusa.com](mailto:Ammoplus@targetsportsusa.com) any time prior to the Membership Term expiration date.

PLEASE NOTE: IF YOU HAVE PAID FOR YOUR MEMBERSHIP USING A CREDIT CARD, UNLESS YOU NOTIFY US BEFORE YOUR MEMBERSHIP EXPIRATION DATE THAT YOU DO NOT WANT TO PARTICIPATE IN AUTO- RENEW OR WISH TO CANCEL YOUR MEMBERSHIP ENTIRELY, YOU UNDERSTAND THAT YOUR AMMO+ MEMBERSHIP WILL AUTOMATICALLY CONTINUE FOR ANOTHER TWELVE (12) MONTHS AND YOU AUTHORIZE US TO CHARGE AND COLLECT THE THEN-CURRENT MEMBERSHIP FEES (AND ANY APPLICABLE TAXES) USING ANY CARD WE HAVE ON FILE FOR YOU. WE MAY DO THIS WITHOUT ANY ADDITIONAL NOTICE TO YOU, UNLESS REQUIRED BY LAW.

## NON-AUTO-RENEW MEMBERS:

For Members that have opted out of the auto-renew feature, their Membership will automatically expire 1 year from the original purchase date. Approximately three (3) days prior to their Membership expiration date, Members will receive an email notification of the expiration date. To avoid a lapse in

benefits, Members should renew by calling the Target Sports USA Customer Service Department prior to the expiration date. Target Sports USA is not responsible for late fees, over limit fees, finance charges or other charges imposed by third-party credit card issuers because of Membership Term renewal. The renewal notice and the customer's ability to cancel are considered sufficient notification of the auto-renew charge.

#### MEMBERSHIP REQUIREMENTS AND LIMITATIONS:

Once an AMMO+ membership is purchased under an account, the email address cannot be changed. The Membership is attached to the email address for the entire membership term. Memberships not paid in full will result in immediate termination of member benefits and you will be responsible for the cost of any benefits/savings received.

Membership is for the Member's use only. Members may not use their Membership benefits to send merchandise to any non-Member or customer. We reserve the right to accept or refuse Membership in our sole discretion, including any renewal Membership.
