I. ELIGIBILITY: The *AMMO+Day Truck Giveaway IV* (the “Sweepstakes” or “Promotion”) is open to registered Target Sports USA AMMO+ or AMMO+ BUSINESS Members (“AMMO+ & AMMO+ BUSINESS Member(s)” or “Member(s)”) and Mail-in Participants (“Mail-in Participant(s)”) who are legal residents of the United States and District of Columbia (D.C) (excluding residents of Alaska, and Hawaii) and are 18 years of age or older (except residents of Alabama and Nebraska, who must be 19 years of age or older, and Mississippi who must be 21 years of age or older) at time of entry. Refer to entry directions in Section IV of these Official Rules. Officers, members, directors, representatives and employees of the Sponsor and any of their respective parent companies, affiliated companies, subsidiaries, dealers, franchisees, licensees, distributors, suppliers, participating retailers, advertising / promotion/judging agencies, persons engaged in the development, production or distribution of materials for this Sweepstakes, Compliance Sweepstakes Services, LLC (collectively, the “Released Entities”) and the immediate family members (defined as spouse, parents, grandparents, children, grandchildren, siblings, - whether biological, adopted, step or in-law) of such individuals, or persons living in the same household as such individuals (whether related or not), are not eligible to participate in the Sweepstakes. Upon completion of the submission and the membership enrollment you are deemed a Participant Member and to receive one (1) entry into the Sweepstakes drawing. You must remain an AMMO+ or AMMO+ BUSINESS Member though the entire Promotion Period to be included in the random winner drawing. Current Members: Update your profile and credit card information. Upon completion of the requested information, you receive one (1) entry into the Sweepstakes drawing. V. DRAWING, NOTIFICATION AND ODDS: Four (4) potential Winners ("Winner(s)") are to be randomly selected on or about November 7, 2024, by a third-party administrator ("the Administrator"), an independent judging organization, whose decisions are final in all matters relating to this Sweepstakes. The potential Winners will be notified by phone and/or e-mail. Total Fourth Prize Pool ARV is \$1,370.00 (USD).

- The AMMO+ Day Event Travel and Accommodations Package:

(a) Vehicle and Bike Prizes: The Prize Winners of the Vehicle and Bike will be solely responsible for: any additional equipment, title, vehicle registration fee, dealer documentation fee, license delivery, dealer prep, freight, emissions inspection, federal, state, and local taxes, insurance, gasoline, maintenance and all other fees and expenses associated with receipt and use of the Vehicle and Bike Prizes. Any additional Vehicle and Bike options will be the responsibility of the Winner. The Vehicle or Bike may not meet safety or emissions testing required in some states, provinces, territories and/or counties/municipalities. Prize Winners of the Grills are responsible for his/her own travel plans and coordination to enable pick up the Grill if it is being picked up from a retail location.

(c) Ammo Prizes will be awarded at the Ammo+ Day Event.

All decisions by Sponsor as to the Prize Winners and Prizes are final. Prize Winner understands and agrees that the Prize award event may be videotaped/photographed. IX. RELEASES: Except, where prohibited by law, participation in this Sweepstakes constitutes each Participant's agreement to hold the Released Entities harmless from and against any losses or damages of any kind, including but not limited to, personal injury or death, resulting from participating in this Promotion or from the acceptance, possession, use or misuse of any Prize awarded or participation in any Prize-related activity. Sponsor makes no representations or warranties of any kind concerning the appearance, safety, or performance of any Prize. Released Entities are not responsible for faulty, incorrect, undeliverable or mis-transcribed phone/e-mail/internet transmissions, incorrect announcements of any kind, technical hardware or software failures of any kind including any injury or damage to any person's computer related to or resulting from participating in or experiencing any materials in connection with the Promotion, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmission that may limit a Participant's (or user's) ability to participate in the Promotion. Sponsor assumes no responsibility for undeliverable e-mails resulting from any form of active or passive e-mail filtering by a Participant's Internet service provider and/or e-mail client or for insufficient space in Participant's e-mail account to receive e-mail. Proof of submitting entries will not be deemed to be proof of receipt by Sponsor. Any entries which are suspected of being fraudulent (including those using robotic, automatic, programmed, or similar methods of participation) will be disqualified, based on determinations made solely by Sponsor. Sponsor reserves the right to prohibit the participation of an individual if fraud or tampering is suspected or if the individual fails to comply with any requirement of participation as stated herein or with any provision in these Official Rules.

XIII. DISPUTES: Except where prohibited, as a condition of participating in this Promotion, Participant agrees that any and all disputes which cannot be resolved between the parties, claims and causes of action arising out of, or connected with this Promotion, or any prizes awarded, or the determination of Winner shall be resolved individually (without resort to any form of class action and with the understanding and agreement that these Official Sweepstakes Rules shall apply), and shall be submitted to arbitration pursuant to the commercial arbitration rules of the American Arbitration Association, then effective.
